I understand that I am responsible for the \$150.00 catalog fee per horse entered, and that a 10% commission will be assessed against any sale price up to \$10,000.00, and that any sale price exceeding \$10,000 will be assessed a commission of \$1000.00 plus 5% of the portion exceeding \$10,000.00. I understand that the terms of consignment include the following fees where applicable: (1) a buy back fee of \$150.00 per horse for horses selling up to \$5,000.00 and \$300.00 per horse for horses selling over \$5,000 (2) a resale fee of \$100.00 per horse; (3) a late paper fee of \$100.00 per horse when signed registration papers are not available at 10:00 a.m. on sale day, and an additional \$25.00 per day per horse when signed registration papers are delayed beyond sale day; (4) a no show fee of \$200.00 per horse for horses catalogued, but withdrawn prior to or not present at sale time. I understand there may be changes in these conditions, and/or in subsequent communications from the sale management, which I hereby fully accept and agree to be the contract between us. I agree to notify Frank Chick's Harness Horse Sales in writing of any wobblers, cribbers, broken bones, chips, nerving, or unsoundness of sight or wind prior to the sale. If any litigation or arbitration should arise as a result of my not notifying Frank Chick's Harness Horse Sales of any of the aforementioned conditions prior to the sale, I agree to indemnify Frank Chick's Harness Horse Sales and hold them harmless for any loss or judgement and shall pay any and all legal costs, including attorney's fees, incurred in any litigation or arbitration against them regarding the sale of this animal or the agency created herein.
